THIS RELEASE IS INTENDED TO DISCHARGE IN ADVANCE THE LEADERSHIP NORTHERN TULARE COUNTY, CITY OF DINUBA, DINUBA CHAMBERS OF COMMERCE AND COMMUNITY SERVICES DEPARTMENT (ITS OFFICERS, AND/OR OFFICIALS, EMPLOYEES, VOLUNTEERS AND AGENTS) FROM ANY AND ALL LIABILITY ARISING OUT OF OR CONNECTED IN ANY WAY WITH MY PARTICIPATION IN SAID ACTIVITY, EVEN THOUGH THAT LIABILITY MAY ARISE OUT OF NEGLIGENCE OR CARELESSNESS ON THE PART OF THE PERSONS OR ENTITIES MENTIONED ABOVE. It is understood that this activity of the Cinco de Mayo Parade involves an element of risk and danger of accidents and knowing those risks I hereby assume those risks. It is further agreed that this waiver, release and assumption of risk is to be binding on my heirs and assigns. I agree to indemnify and to hold the Leadership Northern Tulare County, City of Dinuba, Dinuba Chamber of Commerce (its officers, and/or officials, employees, volunteers and agents) free and harmless from any loss, liability, damage, cost, or expense which they may incur as the result of my death or injury or property damage that I may sustain while participating in said activity.

### PARADE RULES

1. Please go over the parade rules with everyone that is participating.
2. Parade will take place rain or shine, be prepared for rain.
3. Each entry must provide appropriate signage that is large enough to indicate the organization and what it represents.
4. Displays must provide their own power. The Dinuba Chamber of Commerce will not provide electricity or other services.
5. No items shall be thrown, sprayed, discarded (**including candy**).
6. Parade assembly entrants must check in no later than 9:00 am in the staging area *Subject to change*.
7. Entrants arriving after 10:00 am will be placed at the end of the parade (*At the discretion of staff*). Judges will not judge late entrants, and the announcer will only acknowledge the business or organization.
8. Parade riders are to remain seated, in the center and no edges of flatbeds, while the vehicle moves.
9. Flameproof materials and electrical wires must be in good condition.
10. Generators and speakers must be secure at all times, have a fire extinguisher on hand with easy access to an adult.
11. Vehicles/motorcycles clubs must abide by street safety laws. No revving/burnouts.
13. No drugs/alcoholic beverages or smoking of any kind before, during or after the parade. This is a family oriented event.
14. Entrants must take with them all items brought to the event at the end of the parade, including hay, paper etc.
15. All equestrian entries must have a designated person picking up animal droppings before, after and during the parade.
16. Entrants must abide by all safety instructions provided by the Dinuba Chamber of Commerce.
17. The Dinuba Chamber of Commerce reserves the right to exclude/remove entrants whose conduct or entry violate parade criteria or pose safety concerns.
18. The Dinuba Chamber of Commerce reserves the right to reschedule the date of or cancel the parade in events beyond control.
19. In the event of cancellation, or if you do not attend the parade, *NO REFUNDS* will be provided or credited.
